Weighing 27.5kgs and beginning from box 1, Bad Apple completed the 400m trial distance in a time of 22.65. Bad Apple placed 1st in a field of 4 starters winning by 1.5L. Bad Apple has been cleared to race.

Hard Break – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Healesville for failing to chase. Weighing 27.3kgs and beginning from box 5, Hard Break completed the 400m trial distance in a time of 22.75. Hard Break placed 2nd in a field of 4 starters beaten by 1.5L. Hard Break has been cleared to race at all tracks except Healesville.
