Race 1

WELCOME GREAT CHASE COMMUNITY GROUPS

12:09 pm 390m Grade 7 Kalter was slow to begin.

Kiewa River Flo stumbled soon after the start. Kiss Mwah checked off Speaking Spanish on the first turn checking Kalter. Speaking Spanish visibly eased in the home straight.

Speaking Spanish underwent a post-race veterinary examination and was found to have a left groin and hip injury, a 14 day stand down period was imposed. Stewards spoke to handler Mr D Boots, regarding the greyhounds racing manners in the home straight. Acting under the provisions of GAR 69(B)(1), Speaking Spanish was charged with failing to pursue the lure with due commitment (by reason of injury). Mr D Boots reserved his plea. Speaking Spanish must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1) (a) before any future nomination will be accepted.

A post-race sample was taken from Speaking Spanish - the winner of the event.

Stewards opened and adjourned an inquiry into the circumstances from an alleged altercation between trainers Mr P.Kaltsis and Mr J.Hetherton.
