Mr Blake pleaded guilty to the charge, Miss Ore Mac is suspended for 3 months at all tracks and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(b) before any future nomination will be accepted.

Satisfactory Trial results:

Sub Zero Magic – Performed a Stewards Satisfactory trial as connections wish to return the greyhound to racing from retirement. Weighing 26.2kgs and beginning from box 1, Sub Zero Magic completed the 400m trial distance in a time of 23.06. Sub Zero Magic placed 2nd in a field of four beaten by 4.5 lengths. Sub

Zero Magic has been cleared to race.

Patrick Francis – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to a metatarsal fracture. Weighing 34.5kgs and beginning from box 2, Patrick Francis completed the 400m trial distance in a time of 22.75. Patrick Francis placed 1st in a field of four winning by 4.5 lengths. Patrick Francis has been cleared to race.

Secret High – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to the Trainer's ill health. Weighing 32.2kgs and beginning from box 3, Secret High completed the 400m trial distance in a time of 23.36. Secret High placed 3rd in a field of four, beaten by 8.75 lengths. Secret High has been cleared to race.

Bolt Lightning – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Gosford for an Unsatisfactory Performance. Weighing 34.3kgs and beginning from box 8, Bolt Lightning completed the 400m trial distance in a time of 23.56. Lightning Bolt placed 4th in a field of four, beaten by 11.5 lengths. Bolt Lightning has been cleared to race at all tracks except Gosford.
