Chasing Beers placed first in the field of 4 by 1 length and was cleared to race.</p> <p>Humble Inquiry – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at The Meadows for failure to chase by reason of injury. Weighing 32.9kgs and beginning from box 4, Humble Inquiry completed the 400m trial distance in a time of 23.37. Humble Inquiry placed 4th in a field of 4 beaten by 4.75 lengths. Humble Inquiry has been cleared to race at all tracks except The Meadows.</p> <p>Rusty Yaala – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Geelong for failure to chase by reason of injury.
