The winning time of trial was 22.59:</p> <p>Gunmetal Liam finished 1st, Knocka Fella finished 2nd.</p> <p>Gunmetal Liam – Was stood down from racing at Warragul for unsatisfactory performance. Weighing 31.2kg and beginning from box 1 winning by 1 length. Gunmetal Liam has been cleared to race all tracks except Warragul.</p> <p>Knocka Fella – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to an injury to the right triangle. Weighing 32.9kg and beginning from box 8, Knocka Fella completed the 390m trial distance in a time of 22.59. Knocka Fella placed 2nd in a field of 4 beaten by 1 length. Knocka Fella has been cleared to race.</p>
