Nellie Briggs – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Healesville for failing to chase due to injury. Weighing 28.7kg and beginning from box 8, Nellie Briggs completed the 390m trial distance in a time of 22.60. Nellie Briggs placed 2nd in a field of 4 greyhounds beaten by 3.75 lengths. Nellie Briggs has been cleared to race at all tracks except Healesville.
