GRV Stewards concluded an inquiry into an incident that occurred in the vicinity of the kennelling area during the Shepparton greyhound racing meeting on Thursday 19 September, 2019. Evidence was taken from GRV Investigative Steward Mr Kirk Branton and Registered Trainer Mr Simon Humphries. After considering all the evidence, the Stewards issued a charge against Mr Humphries under GAR 86 (q), the particulars being that at the Shepparton Greyhound Racing Club on 19 September 2019, Mr Humphries, being a registered person with GRV, has conducted himself in a manner which was detrimental and prejudicial to the interests and image of greyhound racing. This conduct included using inappropriate language towards a GRV official. Mr. Humphries pleaded guilty to the charge. After considering submissions from Mr Humphries, Stewards issued a fine of \$500, which was wholly suspended for 2 years, pending no further conduct related issues in that time. In determining penalty, Stewards took into consideration:

- Mr. Humphries' submissions regarding his personal circumstances
- The circumstances of the offence
- Mr Humphries guilty plea and good record for conduct related matters
- Specific and general deterrence

•The significance of the image of greyhound racing to GRV

•Denunciation and precedents of a similar nature
