Tonking Home and Feelin' Hot collided on the first turn severely checking Tonking Home. Feelin' Hot visibly eased and turned its head approaching the home turn.</p> <p>Tonking Home underwent a post-race veterinary examination and was found to have bruising to the left hock, spike wounds to the left hock and right hind paw. A 14 day stand down period was imposed.</p> <p>Feelin' Hot underwent a post-race veterinary examination and was found to have spike wounds to both hind legs, no stand down period was imposed. Stewards spoke to representative Ms R. Silva, regarding the greyhounds racing manners approaching the home turn. Acting under the provisions of GAR 69(B)(1), Feelin' Hot was charged with failing to pursue the lure with due commitment (by reason of injury). Ms Silva pleaded guilty to the charge, Feelin' Hot must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.</p> <p>A post-race sample was taken from Feelin' Hot - the winner of the event.</p>

Lady Ruby visibly eased approaching the winning post checking She's Got Cash.</p> <p>Leaping Lydia – Proved difficult to box and will be boxed first in future events in accordance with GAR 52.</p> <p>Lady Ruby underwent a post-race veterinary examination - no apparent injury was reported.</p> <p>Stewards spoke to Mr Neil Parsons, the trainer of Lady Ruby regarding the greyhounds racing manners approaching the winning post. Acting under the provisions of GAR 69(A)(1) Lady Ruby was charged with failing to pursue the lure with due commitment. Mr Parsons pleaded guilty to the charge, Lady Ruby is suspended for 28 days at Cranbourne and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.</p> <p>A post-race sample was taken from Brand New - the winner of the event.</p>

Meeting Comments

The following greyhounds performed a Stewards Satisfactory Trial – The trial took place over 311m with 5 required to trial. The winning time of trial was 18.53:

Violation finished 1st, Kiwi Hustler finished 2nd, Carrow Road finished 3rd, Big Bro Zesta finished 4th and Splish Splash finished 5th.

Violation – Was stood down from racing at Cranbourne for marring. Weighing 25.6kg and beginning from box 1 winning by a neck. Violation has been cleared to race at all tracks.

Kiwi Hustler – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to injury. Weighing 36.3kg and beginning from box 2 beaten by a neck. Kiwi Hustler was not cleared to race as it visibly turned its head on the home turn.

Carrow Road – Was stood down from racing at Warragul for unsatisfactory performance. Weighing 30.7kg and beginning from box 3 beaten by 1.75 lengths. Carrow Road has been cleared to race all tracks except Warragul.

Big Bro Zesta – Performed a weight trial over 311m and a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to injury. Weighing 36.4kg and beginning from box 8 beaten by 8.5 lengths. Big Bro Zesta has been cleared to race at all tracks. Splish Splash visibly eased approaching the home turn and collided with Big Bro Zesta.

Splish Splash – Was stood down from racing at Warragul for marring. Weighing 37.2 and beginning from box 6 beaten by 9.5 lengths. Splish Splash was not cleared to race as it visibly eased approaching the home turn and collided with Big Bro Zesta.
