Hodge's Lane – Was stood down from racing at Bendigo for cramping. Weighing 31.4kg and beginning from box 6 winning by 7.5L. Hodge's Lane has been cleared to race all tracks..

Don't Tell Ange – Was stood down from racing at Sandown for unsatisfactory performance. Weighing 22.4kg and beginning from box 8 beaten by 10.75 L. Don't Tell Ange has been cleared to race all tracks except Sandown.
