Flying Spaniard – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to a monkey muscle injury. Weighing 33.5kgs and beginning from box 1, Flying Spaniard completed the 390m trial distance in a time of 23.04. Flying Spaniard placed 5th in a field of 7 starters beaten by 16.75L. Flying Spaniard has been cleared to race.

Manny Allen – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Mt. Gambier for failing to chase. Weighing 33.6kgs and beginning from box 2, Manny Allen completed the 390m trial distance in a time of 22.88. Manny Allen placed 3rd in a field of 7 starters beaten by 14.5L. Manny Allen has been cleared to race at all tracks except Mt. Gambier.

Paid Too Much – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Ballarat for failing to chase. Weighing 28.0kgs and beginning from box 3, Paid Too Much completed the 390m trial distance in a time of 22.95. Paid Too Much placed 4th in a field of 7 starters beaten by 15.5L. Paid Too Much has been cleared to race at all tracks.

Sharp Spur – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to an extended spell. Weighing 35.7kgs and beginning from box 4, Sharp Spur

completed the 390m trial distance in a time of 23.43. Sharp Spur placed 6th in a field of 7 starters beaten by 22.25L. Sharp Spur has been cleared to race.

Spring Unit – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to change of kennel. Weighing 33.9kgs and beginning from box 6, Spring Unit completed the 390m trial distance in a time of 23.57. Spring Unit placed 7th in a field of 7 starters beaten by 24.25L. Spring Unit has been cleared to race.

Weighing 33.3kgs and beginning from box 7, Hooked On Scotch completed the 390m trial distance in a time of 21.87. Hooked On Scotch placed 1st in a field of 7 starters winning by 14L. Hooked On Scotch has been cleared to race at all tracks except the Meadows.

Miss Winks – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Ballarat for unsatisfactory performance. Weighing 26.5kgs and beginning from box 8, Miss Winks completed the 390m trial distance in a time of 22.85. Miss Winks placed 2nd in a field of 7 starters beaten by 14L. Miss Winks has been cleared to race at all tracks and also cleared to race with blinkers.
