Brindle Delight has been cleared to race at all tracks.

Zippping Riot – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Sale for PEDS. Weighing 33.5kg and beginning from box 8, Zippping Riot completed the 390m trial distance in a time of 23.04. Zippping Riot placed 4th in a field of four starters beaten by 11.75 lengths. Zippping Riot has been cleared to race at all tracks.
