Acting under the provisions of GAR 69(B)(1), Kareda Queen was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Giddings pleaded not guilty to the charge, Kareda Queen was found guilty and must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.

So Criminal underwent a post-race veterinary examination and was found to have a left wrist fracture. So Criminal was humanely euthanased.

All Inn Tilly underwent a post-race veterinary examination and was found to have a laceration to the left hind limb. A 21 day stand down period was imposed.

Following this event Stewards walked the track in the area where All Inn Tilly fell and deemed the track satisfactory for racing.
