Capital Letters lost ground from the 100m mark.</p> <p>Thanks So Much underwent a post-race veterinary examination and was found to have injuries to the right flexor tendon and the right back muscle. A 10 day stand down period was imposed.</p> <p>Capital Letters underwent a post-race veterinary examination and was found to have injuries to both wrists. A 10 day stand down period was imposed.</p> <p>Stewards spoke to Mr. Justin Hetherton, the trainer of Capital Letters regarding its performance in this event. Stewards deemed the performance unsatisfactory, acting in accordance with GAR 71, Capital Letters must perform a Satisfactory Trial (all tracks) before any future nomination will be accepted.</p>

Acting under the provisions of GAR 69(1) My Girl Lilly was charged with marring.
