Acting under the provisions of GAR 69(B)(1), Chucka Khan was charged with failing to pursue the lure with due commitment (by reason of injury). Mr New pleaded guilty to the charge, Chucka Khan must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
