Mr Grenfell pleaded not guilty to the charge, Fyodor Bale was found guilty and suspended for 28 days at Geelong and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
