Hillbilly Bone underwent a post-race veterinary examination and was found to have a right monkey muscle injury and a left wrist sprain. A 21 day stand down period was imposed.

Debattista regarding the greyhounds racing manners approaching the winning post. Acting under the provisions of GAR 69(B)(1), Jackie Jai was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Debattista pleaded guilty to the charge, Jackie Jai must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
