Acting under the provisions of GAR 69(1) Maximum Brew was charged with marring. Mr Bewer pleaded guilty to the charge, Maximum Brew is suspended for 28 days at Geelong and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
