Acting under the provisions of GAR 69(B)(1), Chill Out Diesel was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Johnson pleaded guilty to the charge, Chill Out Diesel must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
