Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.

All persons (both Staff & Participants) attending today, undertook successful health screenings that in-turn, permitted entry to the venue for exclusive race-day functions and operations.

Mr Musselwhite pleaded guilty to the charge, Never Simple is suspended for 28 days at Warragul and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
