All Inn Jason and Galway Lights collided approaching the winning post checking Galway Lights.</p>

Stella Diamond and Snap Decision collided approaching the 250m mark checking Stella Diamond and All Inn Mia. Next Challenge crossed to the outside approaching the 200m mark. All Inn Mia and Anyone Arby collided at the 150m mark checking Anyone Arby and Armageddon Arby. All Inn Mia visibly eased approaching the winning post.
