Mr. Mcrae pleaded not guilty to the charge, Strike was found guilty and suspended for 28 days at Warragul and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.</p> <p>Darnum Dozer underwent a post-race veterinary examination and was found to have a right hind spike wound, a 3 day stand down period was imposed. Stewards spoke to trainer Mr Peter Handley, regarding the greyhounds racing manners in the home straight. Acting under the provisions of GAR 69(B)(1), Darnum Dozer was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Handley pleaded guilty to the charge, Darnum Dozer must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.</p>
