Ms. Holden pleaded guilty to the charge, Airly Liberty is suspended for 28 days at Warragul and must perform a satisfactory trial (all tracks) pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Ricky Raccoon underwent a post race veterinary examination and was found to have an injured left thigh muscle. A 5 day stand down period was imposed. Stewards spoke to trainer Mr. R. Whitford regarding the greyhound's racing manners on the home turn. Acting under the provisions of GAR 69(B)(1), Ricky Raccoon was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Whitford pleaded guilty to the charge, Ricky Raccoon must perform a satisfactory trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
