Rockstar Manners, Maximum Capers and Unknown Warrior collided soon after the start checking Maximum Capers. Raw Zeal faltered on the first turn and lost ground as a result. All Spiced Up and Unknown Warrior collided on the home turn checking All Spiced Up and Blackpool Astro. Rockstar Manners and Unknown Warrior collided in the home straight.

Raw Zeal underwent a post-race veterinary examination and was found to have a right foreleg flexor tendon injury. A 28 day stand down period was imposed.

All Spiced Up underwent a post-race veterinary examination and was found to have a right foreleg pectoral muscle injury and right hock sprain. A 14 day stand down period was imposed.

Unknown Warrior underwent a post-race veterinary examination and was found to have an abrasion to the central pad on the left hind, and right and left foreleg trapezius muscle injuries. A 10 day stand down period was imposed. Stewards spoke to Mr C Stanton, the handler of Unknown Warrior, and issued a warning regarding the greyhound's racing manners on the home turn and in the home straight.

Buy The Dip – In accordance with GAR 73, presented for a re-vet at the conclusion of kennelling as the greyhound was found to be injured at Ballarat on 24/8/20. Buy The Dip was examined by the on-track veterinarian and found to be free from injury. Buy The Dip was Cleared to race.
