<p>Race 1 EVERY RACE LIVE ON THE WATCHDOG APP 6:58 pm 390m Maiden</p>	<p>Due to Government Social Distancing Laws under COVID-19 and acting in accordance with GAR 51 (10), the Stewards have directed that the boxing process in Victoria will revert to and continue under the 4-wave model being 1 & 5 boxed first, followed by 3 & 7, followed by 2 & 6, followed by 4 & 8. Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.</p> <p>All persons (both Staff & Participants) attending today, undertook successful health screenings and wore face-masks that in-turn, permitted entry to the venue for exclusive race-day functions and operations.</p> <hr/> <p>A pre-race sample was taken from Charlotte Tulip.</p> <p>Reckless Roger and Livia Bale were quick to begin. Dazzling Dippy was slow to begin.</p> <p>Reckless Roger checked off Livia Bale soon after the start. Reckless Roger, Dazzling Dippy and Blair's Tulip collided approaching the first turn checking Reckless Roger and Dazzling Dippy. Reckless Roger and Dazzling Dippy collided approaching the first turn severely checking both greyhounds. That's Easy, Blair's Tulip and Charlotte Tulip collided on the first turn. That's Easy checked off Blair's Tulip approaching the home turn and again approaching the winning post.</p> <p>Reckless Roger underwent a post-race veterinary examination and was found to have a left monkey muscle injury. A seven day stand down period was imposed.</p> <p>A post-race sample was taken from Livia Bale - the winner of the event.</p>

Aston Colossus began awkwardly and lost considerable ground as a result.</p> <p>Zippering Blossom and Zippering Coby collided on the first turn checking Zippering Coby who stumbled as a result. Zippering Blossom raced wide approaching the home turn and entering the home straight. Chloe Exotic and Aston Colossus collided entering the home straight.</p> <p>Aston Colossus underwent a post-race veterinary examination - no apparent injury was reported.</p> <p>Zippering Coby underwent a post-race veterinary examination and was found to have a left deltoid muscle, a left hamstring and a right triangle muscle injury. A seven day stand down period was imposed.</p> <p>A post-race sample was taken from Sweet Petit - the winner of the event.</p>

<p>Race 3 SIRENS ON ICE HT1 7:38 pm 450m Mixed 6/7 Heat</p>	<p>A pre-race sample was taken from Chatterbox Tilly.</p> <p>Fabriola Yes was slow to begin.</p> <p>Tiggerlong Bundy, Fabriola Yes and Aratuza Bale collided soon after the start, checking Aratuza Bale. Perfect Glory and Aston Holdings collided soon after the start. Call Me Tiger and Chatterbox Tilly collided on the first turn. Perfect Glory crossed to the rails on the first turn checking Chatterbox Tilly, Call Me Tiger, Tiggerlong Bundy and Blaviken Bale, causing Call Me Tiger to fall. Blaviken Bale, Tiggerlong Bundy and Aston Holdings collided on the home turn. Stewards spoke to Representative Mr G. Dailly regarding the greyhound's racing manners in the home straight. Acting under the provisions of GAR 69(1) Blaviken Bale was charged with marring. Mr Dailly pleaded guilty to the charge, Blaviken Bale was found guilty and suspended for 28 days at Ballarat and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.</p>
