Mrs. Russell pleaded guilty to the charge, Airly Spence was found guilty and suspended for 28 days at Warragul and must perform a Satisfactory Trial in accordance with GAR 69A(2)(a) and pursuant to GAR 72, before any future nomination will be accepted.
