Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.</p> <p>All persons (both Staff & Participants) attending today, undertook successful health screenings and wore facemasks that in-turn, permitted entry to the venue for exclusive race-day functions and operations.</p> <p>Side Hustle and Chain Breaker collided on the first turn.
