Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.

All persons (both Staff & Participants) attending today, undertook successful health screenings that in-turn, permitted entry to the venue for exclusive race-day functions and operations.

Acting under the provisions of GAR 69(A)(1) Jabril Bale was charged with failing to pursue the lure with due commitment. Ms Gurry pleaded guilty to the charge, Jabril Bale is suspended for 28 days at Warrnambool and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
