Handlers are required to exit the area after boxing and maintain their 1.5 m distance from other handlers and staff at all times.</p> <p>All persons (both Staff &amp; Participants) attending today, undertook successful health screenings and wore face-masks that in-turn, permitted entry to the venue for exclusive race-day functions and operations.</p> <p>Brother Soldier was quick to begin.
