A 10 day stand down period was imposed.</p> <p>Invictus Ethan underwent a post-race veterinary examination - no apparent injury was reported.</p> <p>Stewards spoke to Mrs Marlene Schmidt, the trainer of Invictus Ethan regarding the greyhound's racing manners on the home turn. Acting under the provisions of GAR 69(1) Invictus Ethan was charged with marring. Mrs Schmidt pleaded guilty to the charge, Invictus Ethan was found guilty and suspended for 28 days at Sandown and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.</p> <p>A post-race sample was taken from Mepunga Reject the winner of the event.</p>
