Acting under the provisions of GAR 69B (1), Snapper Smith was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Capuano pleaded not guilty to the charge, Snapper Smith was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and GAR 72, before any future nomination will be accepted.</p> <p>Girls Got Rhythm underwent a post-race veterinary examination, at the trainer's request, and was found to have a right hind toe dislocation. A 7 day stand down period was imposed.</p> <p>A post-race sample was taken from Snapper Smith - winner of the event.</p>
