Mr. Portelli pleaded guilty to the charge, That's Easy was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and GAR 72, before any future nomination will be accepted.

Nice And Easy underwent a post-race veterinary examination and was found to have a right back muscle injury. A 28 day stand down period was imposed.
