In accordance with GAR 75 (1), the Stewards requested Ms. Dudley to report as soon as practicable anything that may have affected the running of Jimmy Goes Bang in the event, which was not noted by Stewards during or immediately after the event.

A post-race sample was taken from Atomic Icon - winner of the event.

Supplementary Report

Jimmy Goes Bang - Subsequent to the race meeting Trainer Ms R. Dudley advised that the greyhound was examined and found to have a left thigh, right triangle and right quadriceps injury. Ms Dudley advised that the greyhound would have a brief let up prior to racing again.

Race 10

PARKER PUMPS (250+ RANK) 6:15 pm 400m Grade 5 A pre-race sample was taken from Southern Thunder.

Southern Thunder underwent a pre-race veterinary examination and was deemed suitable to race.

Winlock Dyno was quick to begin. Riverdale Bear and Southern Thunder were slow to begin.

Mr. Daver checked off Flying Brae on the first turn. Southern Thunder brushed the running rail on the first turn. Mr. Daver raced wide in the home straight. Trout and Flying Brae collided in the home straight.

Southern Thunder underwent a post-race veterinary examination after an incident in the catching pen and was found to have a bruising and spike wound to the left stopper, bruising and spike wound to the right tarsal and a left hip injury. A 28 day stand down period was imposed.

Nana Jill – Fail to Chase due to Injury - Field of 7, Distance 400m, Weight 26.7 kg, Box 1, Placed 2nd, Time Run 23.28 - Comment: Cleared All Tracks.

Tinker Mighty – Unsatisfactory Performance - Field of 7, Distance 400m, Weight 32.0 kg, Box 2, Placed 3rd, Time Run 23.42 - Comment: Not Cleared. Eased in the home straight. Post-trial veterinary examination found to have a left monkey muscle injury. A 14 day stand down period was imposed.
