Acting under the provisions of GAR 69(1) Dr. Xander was charged with marring. Ms. Gill pleaded not guilty to the charge, Dr. Xander was found guilty and suspended for 28 days at Sandown and must perform a Satisfactory Trial in accordance with GAR 69(2) and GAR 72, before any future nomination will be accepted.</p>
