Chart Topper underwent a post-race veterinary examination and was found to have a right foreleg deltoid muscle injury, a five day stand down period was imposed. Stewards spoke to trainer, Mr Robin Moore regarding the greyhounds racing manners approaching the winning post. Acting under the provisions of GAR 69B (1), Chart Topper was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Moore pleaded not guilty to the charge, Chart Topper was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.

Aston Corinna underwent a post-race veterinary examination and was found to have right hindleg calf and hamstrings injuries. A seven day stand down period was imposed.

Stewards spoke to Mr George Dailly, the handler of Aston Corinna regarding the greyhound's racing manners in the home straight. Acting under the provisions of GAR 69(1) Aston Corinna was charged with marring. Mr Dailly pleaded guilty to the charge, Aston Corinna was found guilty and suspended for 28 days at The Meadows and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.
