Crown Sally was found guilty and suspended for 28 days at Sale and must perform a Satisfactory Trial in accordance with GAR 69A(2)(a) and pursuant to GAR 72, before any future nomination will be accepted.</p> <p>The Stewards discussed the frequency of racing of Crown Sally with the trainer Ms. Tammy Kennedy-Harris and noted their comments.</p> <p>Stewards noted that the lure was delayed by approximately 7 seconds after the green light was turned on due to a problem with the catching pen flap. After viewing all the available race footage and acting on their observations, Stewards declared that no greyhound was disadvantaged by the delay and gave the all clear.</p> <p>Club officials, Joel Anderson and Balin Greenwood were reminded of their responsibilities regarding preparing the catching pen for racing. This matter was referred to the Club Manager for further consideration and remediation.</p>
