Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.</p> <p>All persons (both Staff & Participants) attending today, undertook successful health screenings and wore face masks/covers that in-turn, permitted entry to the venue for exclusive race-day functions and operations.</p> <hr/> <p>Slim Girl and Nine Wine Wine were slow to begin.</p> <p>Slim Girl checked off Nine Wine Wine soon after the start. Villanelle marred Queen Lisa on the first turn checking Villanelle, Queen Lisa and Orange Justice.</p> <p>Monument Valley underwent a post-race veterinary examination and was found to have a laceration to the left hindleg. A 14 day stand down period was imposed.</p> <p>Villanelle underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to Mr S. Menegazzo, the representative of Villanelle regarding the greyhound's racing manners on the first turn. Acting under the provisions of GAR 69(1) Villanelle was charged with marring. Mr Menegazzo pleaded guilty to the charge, Villanelle is suspended for 28 days at Geelong and must perform a Satisfactory Trial pursuant to GAR 69(2)(a) before any future nomination will be accepted.</p> <p>Maddingley Park underwent a post-race veterinary examination and was found to have a fractured right radius and fractured right ulna. Maddingley Park was humanely euthanised.</p>
