Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.

All persons (both Staff & Participants) attending today, undertook successful health screenings and wore face-masks that in-turn, permitted entry to the venue for exclusive race-day functions and operations.

Dark Pearl - Late scratching at 8:36am due to the greyhound being on season (GAR 24). A 28 day stand down period was imposed.

Especially Eager underwent a post-race veterinary examination and was found to have an injury to the left back muscle and a laceration on the left stopper. A 14 day stand down period was imposed. Stewards spoke to trainer, Mr Cameron Knott regarding the greyhounds racing manners on entering the home straight. Acting under the provisions of GAR 69B (1), Especially Eager was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Knott pleaded guilty to the charge, Especially Eager was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.
