Acting under the provisions of GAR 69(B)(1), Will's Bella was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Baker pleaded not guilty to the charge, Will's Bella was found guilty and must perform a Satisfactory Trial pursuant to GAR 69(B)(1)(a) before any</p> <p>Rough Ride underwent a post-race veterinary examination - no apparent injury was reported.
