Handlers are required to exit the area after boxing and maintain their1.5m distance from other handlers and staff at all times. All persons (both Staff & Participants) attending today, undertook successful health screenings and wore face-masks/covers that in-turn, permitted entry to the venue for exclusive race-day functions and operations. Acting under the provisions of GAR 69(B)(1), Just The Marjen was charged with failing to pursue the Iure with due commitment (by reason of injury). Mr. Jensen pleaded not guilty to the charge, Just The Marjen was found guilty and must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted. Belle Curve underwent a post-race veterinary examination and was found to have an elevated temperature. A 7 day stand down period was imposed.
