Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.

All persons (both Staff & Participants) attending today, undertook successful health screenings and wore facemasks/coverings that in-turn, permitted entry to the venue for exclusive race-day functions and operations.

At a subsequent inquiry, the Stewards charged trainer, Mrs V Sultana with a breach of GAR 31 for failing to present the correct greyhound to the Stewards for this event. Mrs V Sultana, representative of Hurricane Miami, pleaded guilty to the charge on behalf of Mrs V Sultana, who was fined \$250. The 28 days stand-down on Hurricane Miami was revoked.

Southern Bell was slow to begin.

Damaged and Rajah collided soon after the start, checking Our Boy Benny and Rajah. Damaged checked off Amlin Frozen on the first turn. Our Boy Benny and Amlin Frozen collided on the home turn.

Mr Richards pleaded guilty to the charge, Bull's Roar was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.
