Due to Government Social Distancing Laws under COVID-19 and acting in accordance with GAR 51 (10), the Stewards have directed that the boxing process in Victoria will continue under the 4-wave model being 1 & 5 boxed first, followed by 3 & 7, followed by 2 & 6, followed by 4 & 8. Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.

After hearing evidence from Mr Conway, viewing all the available race footage and acting on their observations, a warning was issued regarding the greyhound's racing manners approaching the winning post.

Galaxy Queen, Ton Eighty and Meat Murphy collided on the second turn. Jayville Tahlia and Ultra Lightbeam collided on the second turn checking Jayville Tahlia. Ton Eighty and Galaxy Queen collided on the third turn. Ton Eighty marred Galaxy Queen several times on the home turn and again in the home straight severely checking Galaxy Queen.

Ton Eighty underwent a post-race veterinary examination - no apparent injury was reported.

Stewards spoke to Mr Troy Dorrington, the trainer of Ton Eighty regarding the greyhound's racing manners on the home turn and again in the home straight. Acting under the provisions of GAR 69(1) Ton Eighty was charged with marring. Mr Dorrington pleaded guilty to the charge, Ton Eighty was found guilty and suspended for 28 days at Sandown and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.

Sailing Shoes underwent a post-race veterinary examination and was found to have tarsal sprain to both the let and right hocks. A5 day stand down period was imposed. Stewards spoke to Mr R Palmer, trainer of Sailing Shoes regarding the greyhounds racing manners on the third turn. Acting under the provisions of GAR 69B (1), Sailing Shoes was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Palmer pleaded not guilty to the charge, Sailing Shoes was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.

Razor Burn underwent a post-race veterinary examination and was found to left back muscle injury. A 60 day stand down period was imposed.
