Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.</p> <p>All persons (both Staff & Participants) attending today, undertook successful health screenings and wore face-masks/covers that in-turn, permitted entry to the venue for exclusive race-day functions and operations.</p> <p>Meehan Ziggy was quick to begin. Acting under the provisions of GAR 69B (1), Dancing Molly was charged with failing to pursue the lure with due commitment (by reason of injury). Mr O'Kane pleaded guilty to the charge, Dancing Molly was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.</p>
