Odd Gem, So Joe Mac and Blazin' Poppy collided on the first turn, checking So Joe Mac. Odd Gem, Blazin' Poppy and Ripplebrook Mack collided on the first turn, causing Blazin' Poppy to fall and checking Marshall Dillon. Blazin' Poppy underwent a post-race veterinary examination and was found to have sustained a right deltoid muscle injury. A14 day stand down period was imposed.
