Acting under the provisions of GAR 69A(1) Deed's Delight was charged with failing to pursue the lure with due commitment. Mr Clark pleaded guilty to the charge, Deed's Delight was found guilty and suspended for 28 days at Shepparton and must perform a Satisfactory Trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.

My Father's Son underwent a post-race veterinary examination - no apparent injury was reported, trainer Mr Micheal Chilcott declined to have the greyhound re-vetted. Stewards spoke to Mr Chilcott, the trainer of My Father's Son regarding the greyhound's racing manners approaching the winning post. Acting under the provisions of GAR 69A(1) My Father's Son was charged with failing to pursue the lure with due commitment. Mr Chilcott pleaded guilty to the charge, My Father's Son was found guilty and suspended for 28 days at Shepparton and must perform a Satisfactory Trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.

A post-race sample was taken from Vice Grip - the winner of the event.
