Acting under the provisions of GAR 69A(1) Scott Worth It was charged with failing to pursue the lure with due commitment. Ms Bowles pleaded not guilty to the charge, Scott Worth It was found guilty and suspended for 3 months at all tracks and must perform a Satisfactory Trial in accordance with GAR 69A (2) and pursuant to GAR 72, before any future nomination will be accepted.</p>
