Mr Irby pleaded guilty to the charge, Aztec Blaze was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.</p> <p>Pearl's Entity underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to Ms Lyn Smith, the trainer of Pearl's Entity regarding the greyhound's racing manners approaching the winning post. Acting under the provisions of GAR 69(1) Pearl's Entity was charged with marring. Ms Smith pleaded guilty to the charge, Pearl's Entity was found guilty and suspended for 28 days at Warragul and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.</p>
