All persons (both Staff & Participants) attending today, undertook successful health screenings and wore face masks that in-turn, permitted entry to the venue for exclusive race-day functions and operations.

A pre-race sample was unable to be obtained from Modern Shadow, a post-race sample was subsequently taken.

Mr Weis pleaded guilty to the charge, Extreme Days was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.

Stewards spoke to Mr. Robert Proctor regarding the racing manners of Capital Kay on the home turn. After hearing evidence from Mr. Proctor, viewing all the available race footage and acting on their observations, Stewards took no further action.
