## Race 1

Handlers are required to exit the area after boxing and maintain their 1.5 m distance from other handlers and staff at all times.

All persons (both Staff & Participants) attending today, undertook successful health screenings and wore face-masks that in-turn, permitted entry to the venue for exclusive race-day functions and operations.

Saint Bogan – Late scratching at 11:07 am on the advice of the On–Track Veterinarian (GAR 37) due to a papilloma. A seven day stand down period was imposed.

Black Booker was quick to begin.

Acting under the provisions of GAR 69B (1), Maximum Cook was charged with failing to pursue the lure with due commitment (by reason of injury). Ms Wilson pleaded guilty to the charge, Maximum Cook was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.
