Evans did not act in any official capacity that may have in any way, affected the outcome of this event.</p> <p>Gem Victorem and Holding Hope collided on the first turn. Three Kisses and Kraken Rita collided on the home turn checking both greyhounds. Holding Hope checked off Kraken Rita entering the home straight checking Kraken Rita.
