At the commencement of kennelling, the outside temperature was 32.9 degrees and the kennel temperature was 17.2 degrees. The Stewards continually monitored the temperature at the venue as per the GRV Hot Weather Policy.

Mr Seymour pleaded not guilty to the charge, Bee Lucky Banjo was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.
